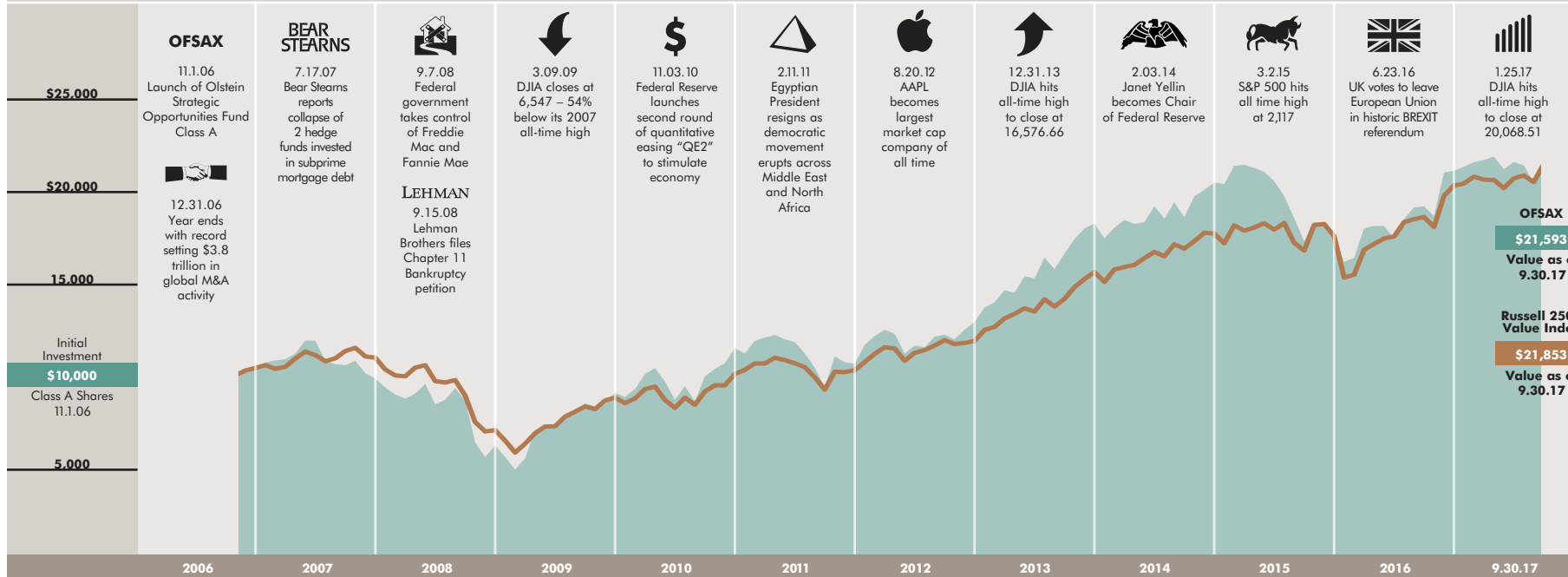


**Olstein Strategic Opportunities Fund

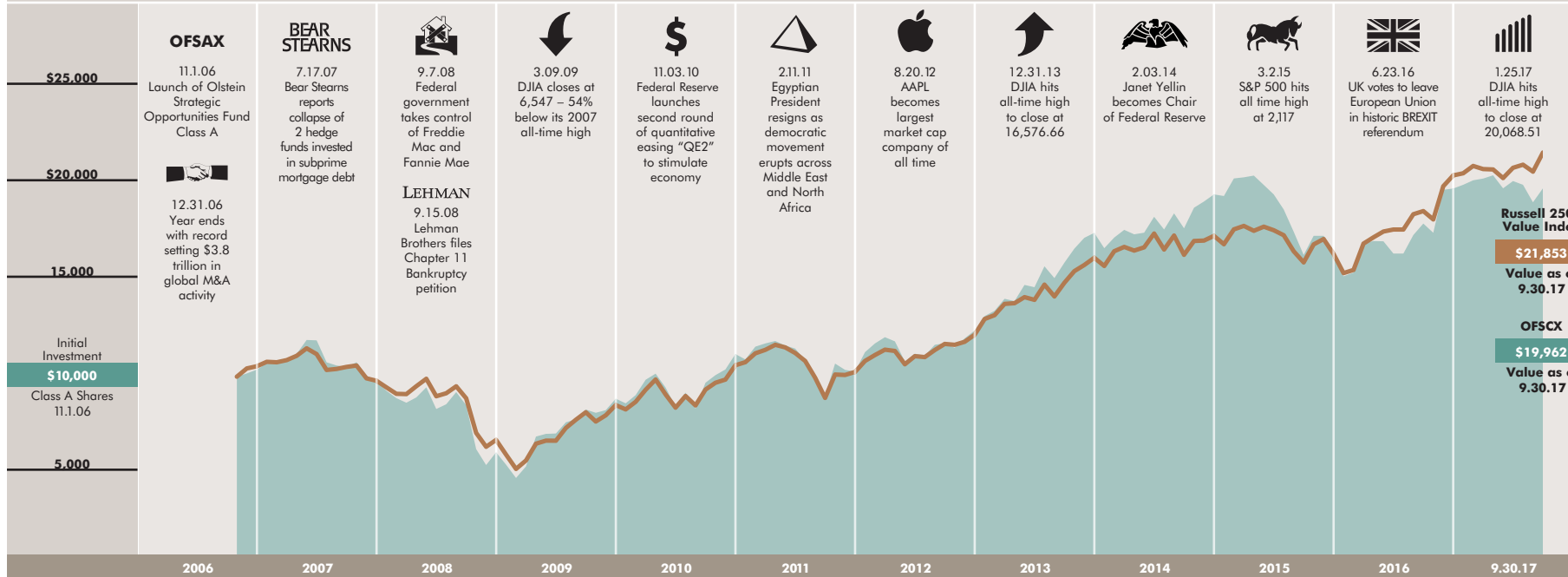
